The Court ordered that the respondent is prohibited from:

Stalk the protected person(s)

NOTE - A person stalks another person if he/she engages in a course of conduct with the intention of causing physical or mental harm to that person including self harm, or arouses apprehension or fear in that person for his or her own safety or that of any other person.

Commit prohibited behaviour towards the protected person(s).

NOTE - Prohibited Behaviour is assault, sexual assault, harassment, property damage or interference, or making a serious threat.

Attempt to locate, follow the protected person(s) or keeping him/her/them under surveillance.

Publish on the internet, by email or other electronic communication any material about the protected person(s).

Contact or communicate with a protected person by any means.

Approach or remain within 25 metres of a protected person.

Go to or remain within 200 metres of

[REDACTED] AND THE BLOCK ARCADE COLLINS STREET

or any other place where a protected person lives or works.

Get another person to do anything the respondent must not do under this order.

THE RESPONDENT MAY:

(a) communicate with a protected person through a lawyer in writing in the form of a letter through the post or by email only,

BUT ONLY IF the respondent does not stalk the protected person or engage in prohibited behaviour while doing so.

This intervention order expires at midnight on 1/1/2030, unless extended or varied prior to that time.
